It should include statements: "Conceptualization, X.X. and Y.Y.; methodology, X.X.; investigation, X.X.; writing—original draft preparation, X.X.; writing—review and editing, X.X.; visualization, X.X.; supervision, X.X.; All authors have read and agreed to the published version of the proceeding. Authorship should be limited only to those who have made significant contribution to the overall study.

*Funding*: For the proceedings that received any kind of financial support use the phrase: "This research was funded by NAME OF FUNDER, grant number XXX". If the work did not received fundings it should put a statement: "This work did not receive funding".

*Informed Consent Statement*: optional; use the phrases: "Informed consent was obtained from all subjects involved in the study." or "Patient consent was waived due to REASON (please provide a detailed justification)." or "Not applicable" for studies not involving humans.

Acknowledgments: optional; in this section all who made contributions, but are not listed as authors or in funding section, can be mentioned. This can include administrative or technical support, or donations in kind (e.g., materials used for experiments).
